Committee on Legislative & Government Relations Chair: Leocadia Conlon

Legislative focus included:

- Protection of reproductive health access and rights
- Tobacco and vaping
- Expanding the scope of practice for PAs and APRNs to expand access to care
- DOE to stock bronchodilators at schools for emergency use during an asthma attack
- Extend the sunset date for the early lung cancer screening task force

Submitted 22 testimonies for 9 bills

Member/community organizations supported:

- American College of Obstetricians and Gynecologists, Hawai'i Chapter
- American Lung Association, Hawai'i Chapter
- Hawai'i Public Health Institute
- Hawai'i Academy of PAs (and the state medical board via the Hawa'ii Academy of PAs)
- Hawai'i State Center for Nursing
- SB1 Protection of reproductive health access and rights; increases access to abortion care by PA & APRNs
- SB957 Establishes criminal offense of unlawful shipment of tobacco products
- HB664 & SB599 Expands the class of healthcare providers under whom respiratory therapists may practice respiratory care to include physician assistants and advanced registered nurses
- HB1448 & SB1443 Authorizes the DOE to stock at school for emergency use during an asthma
- HB1449 Amends Act 162, SLH 2022, to extend the sunset date for the early lung cancer screening task force and extend the date for the task force to submit reports to the legislature
- HB551 Prohibits sale of flavored tobacco products
- HB₅₃₇ Establishes a tax of 70% for electronic smoking devices and e-liquid products

ARGC Report By Tenaya Jackman

Report of the Affiliate Representative to the Governing Council of APHA

- APHA had a successful Annual Meeting in Atlanta, Georgia, November 12-15. The meeting theme *Creating the Healthiest Nation: Overcoming Social and Ethical Challenges* drew 13,000 attendees and hundreds of sessions. Both virtual and in-person sessions were available. The new APHA strategic plan was introduced. There were several presentations about public health in Hawaii. Many sessions addressed ways forward for public health given the experience of COVID-19, misinformation, reproductive health, climate change, mental health and equity. Access to digital content is available through 12/31. The Governing Council approved almost all policies, including a late breaker recommending a ceasefire in the Israel-Hamas war.
- The incoming APHA President is Ella Greene-Moton, who will make a short presentation at today's meeting. The new President-Elect is Deanna Wathington.
- APHA will hold its next meeting in Minneapolis, MN, October 27-30, 2024.
- National Public Health Week 2024 is April 1-7. The theme is Protecting, Connecting and Thriving: We Are All Public Health
